**PERSONNEL ELIGIBLE FOR CONSIDERATION:** This position is open to members of the Montana Air National Guard (MTANG). This is a gender neutral position. Minimum grade for this position is TSgt/E-6. A Secret Clearance is required for this position. This position is not AFSC restricted however all applicants must meet or exceed the minimum standards for entry to the 2G0X1 AFSC.
