3. DUTY PERFORMANCE INFORMATION: The Joint Force Headquarters – Montana (Air) is soliciting applications from enlisted military members who are interested in transferring to Joint Force Headquarters, Montana Air National Guard. Applicants will be considered based upon their potential contributions to our Joint Force mission

4. ELIGIBILITY:

a. Must be eligible for promotion to TSgt (E-6).

b. Meet the physical profile requirements of the AFSC assigned or have appropriate waiver(s).

c. Must be eligible for award of AFSC 5/7-level qualification in your current assignment.

5. APPLICATION PROCESS: Submit a one page letter of intent, including a brief background of your military and civilian experience and how you believe your experience (both military and civilian) will contribute to the success of the Joint Force mission.
