SUBJECT: Updates to the Decentralized State Incentive Program (DSIPP) and the Guard Incentive Management System (GIMS)

1. References:

2. Purpose: To notify command and units of the DSIPP/GIMS policy.

a. The implementation date of the new GIMS will not take place on 01 OCT 11. GIMS is currently being field tested to ensure a smooth fielding before going live.

b. Until further notice, states will continue to utilize DSIPP Policy dated 29 March 2011 and the two attached EIOMS dated 23 September 2011.

(1) Update 11-023 dated 23 September 2011 and effective 01 October 2011 changes general bonus eligibility requirements (Enclosure 2).
